RE: Registration status of Azida Charitable Education o/a Azida College of Technology Ltd.

Immediate Suspension under section 20 of the *Private Career Colleges Act, 2005*

The Ministry received your correspondence dated April 30, 2008 in which you indicate that due to lack of student enrolment, the PCC has had to vacate its inspected campus and has no current operating location.

Pursuant to section 20 of the *Private Career Colleges Act, 2005*, I hereby give notice that Azida College of Technology Ltd.'s registration is suspended, **effective immediately.**

As a result of my decision,

1. Effective immediately, Azida College of Technology Ltd. may no longer continue to enrol students in courses approved under the Act.
2. Effective immediately, Azida College of Technology Ltd. is prohibited from advertising in any media that it is offering programs that required to be approved under the Act.

In your correspondence you indicated that at the appropriate time, a new business location will be secured. Securing a new location for your school would address the reasons for this immediate suspension. If the new location is approved, this would allow the Superintendent to lift this suspension. Therefore, please ensure that once you have a new location, the Ministry is provided with written confirmation of the new campus

location by way of a Notification of Change Form and required documentations. This form is available online at www.serviceontario.ca.

Azida College of Technology Ltd. has the right to appeal this suspension. Information on the appeal process is set out in Schedule "A", attached to this letter.

Schedule "A"

Entitlement to Hearing by Licence Appeal Tribunal:

If **Azida College of Technology Ltd.** disagrees with the Superintendent's decision, it is entitled to a hearing by the Licence Appeal Tribunal ("Tribunal") if it mails or delivers to both the Superintendent of Private Career Colleges and the Tribunal, a notice in writing requesting such a hearing.

Such notice must be delivered, **by registered mail or courier**, to the Superintendent and to the Tribunal by **June 4, 2008**.

If **Azida College of Technology Ltd.** does not require a hearing by the Tribunal as set out above, the decision to suspend the registration will continue until the registration is revoked or until **Azida College of Technology Ltd.'s** registration lapses. If **Azida College of Technology Ltd.** does not request a hearing by **June 4, 2008** the Superintendent will immediately thereafter carry out the proposal to revoke **Azida College of Technology Ltd.'s** registration.

In the case of a provisional/immediate suspension issued under section 20 of the Act, a request for a hearing by Azida College of Technology Ltd. does not stay the suspension: the suspension continues, unless otherwise directed by the Tribunal.

If **Azida College of Technology Ltd.** does choose to request a hearing by the Tribunal, the notice to the Tribunal should be addressed to:
